County Attorney Report

There were no comments provided.

County Manager Report

<u>Assistance</u>

County Manager Lieberman stated that the County does provide rental and utility assistance. She encouraged anyone who needs assistance with unemployment, food, or any other needs to contact the County's Community Support Services Department.

Reopening of the County

County Manager Lieberman advised that the County is working with all the managers from municipalities to ensure that the rules are consistent. She is working with Risk Management and County Directors to develop a plan to safely reopen operations for the County. Efforts are being made to secure the necessary PPE to do the job safely.

Commissioner Cornell has received reports that the County has a different interpretation of the Governor's Order than the City of Gainesville in regard to construction and permits. He would like for the County to be consistent with the City of Gainesville.

County Manager Lieberman stated that she believes the County has the correct interpretation of the Governor's Orders. The County has sought guidance from the Governor's Office but has not received a response. Mrs. Lieberman stated that she will speak to the City of Gainesville and provide an email to the Board with the findings.

Commissioner Wheeler inquired about the impending Governor's order for reopening as far as timeline, requirements, and categories of businesses.

County Attorney Torres and Chair Hutchinson presented comments.

Mental Health Needs

Commissioner Wheeler stated there is a need to have a ZOOM meeting to discuss the mental health issues in the County and ways to address them. She also advised that she received some complaints that citizens in the City of Alachua are having difficulty connecting with the County's 311 help line.

Chair Hutchinson requested that the County Manager check to see that residents with the 386 Area Code have access to the system.

Food Provision Programs

Commissioner Chestnut stated that Farm Share on April 23, 2020 served 1,750 families in the parking lot of the Oaks Mall. He advised that community partners are doing a tremendous job meeting the needs throughout the County.

Mr. Chestnut advised that residents of Mayor Wood Apartments in Alachua have received a notice that they will have to make a decision whether to stay with the Alachua County Housing Authority or go with the Section 8 program for relocation. He would like the County Manager to look into the matter and have the Housing Authority report back to the Board. He feels that during this pandemic is the wrong time for the Housing Authority to pursue this project. Mr. Chestnut further advised that he has received many

calls from Hair dressers wishing to reopen. They have been hit particularly hard by the closure.

County Manager Lieberman advised that the Governor has a hotline open and that anyone wishing to provide input on reopening should contact the hotline and provide their input.

Code Enforcement Deadlines

Commissioner Cornell inquired if the deadlines have been administratively extended or what the process is at this time for Code Enforcement cases and Development Review Applications. He is concerned that the County is not requiring a deadline for Code Enforcement and Development Review Deadlines that cannot be met because of the shutdown orders.

Deputy County Manager Jim Harriott stated that he will send a detailed email to the Board regarding the matter. Staff is reviewing the matter as the environment continues to change. He stated that there are a few issues with items that need to go before Code Enforcement Board and the Board will have a heavy Public Hearing schedule approaching.

Mr. Harriott advised that one possible course of action is that staff may refer the Code Enforcement issues to a special magistrate which would reduce the number of participants needed to address the matters.

Mask Requirements

Commissioner Cornell stated that Miami/Dade and Palm Beach have mandatory face coverings and he would like to see Alachua County follow suite.

Health Department Director Paul Myers stated that the CDC guidance is that mask should be voluntary. He advised that there is not a consensus on the science on this matter. He stated that people with asthma and Closter Phobia can have breathing difficulty caused by the mask. He advised that the University of Minnesota Infectious Disease has a very good paper on the matter if anyone wishes to review it.

Commissioner Byerly, Commissioner Wheeler, Commissioner Byerly, County Attorney Torres, Chair Hutchinson, Commissioner Chestnut, Commissioner Byerly, and Chair Hutchinson presented comments.

By consensus, the Board agreed to schedule for Friday, May 1, 2020 at 10:00 a.m. to discuss the Governor's Order and the County's Order. Chair Hutchinson requested County Attorney Torres send the draft order to the Board so they may review it prior to the meeting.

Library System

Commissioner Byerly inquired if the library is working on reopening the library district in a safe manner. He stated that the system offers tremendous services to the community and he would like the Governing Board to consider opening in a safe manner.

Tele-conferencing

Commissioner Byerly inquired of the County Manager what utilization of teleconferencing the County has used to conduct business. He would like the County to pursue its use even after this pandemic from efficiency stand point.

County Manager Lieberman stated that the administration is looking to implement regular use tele commuting/tele-conferencing. She stated she feels there is a large opportunity to make the operations of the County more efficient.

Supervisor of Elections Mailer

Chair Hutchinson stated that he has requested that the Supervisor of Elections create a mailer for every household encouraging them to request a mail in ballot. Mr. Hutchinson stated that the County will need to fund this item.

By consensus the Board referred to the County Manager to return to the Board with recommendations to finance a mailer to voters regarding mail in ballots.

Commissioner Wheeler advised that the complaints she received about the County's 311 service not working came from the 386 area code so it very well may be an issue with the area code.
