Inclusionary Housing Discussion 22-0357

Ivy Bell, Senior Planner in Planning and Development presented the above item.

Traditional Neighborhood Design (TND) Allowances/Requirements

TND require higher minimum densities and allow for higher maximum bonus densities. They also allow for and require nonresidential development for a mixed use component of the project.

Commission Comment

Commissioner Cornell would like to refer to staff to ask GRU how they are dealing with the overbilling of unincorporated customers on their 35 or 36 days on their bill.

Commissioner Prizzia asked to refer to the Affordable Housing Committee to explore the idea of working with the local housing finance authorities on the idea of providing more support for those that are renting from properties that benefit from the housing authority. For example, rent to own or a rent subsidy that goes into a savings account that allows for tenants to have.

Commissioner Eagle-Glenn asked for clarification on the jurisdiction of the area where a homeless encampment is located east on Archer Road. She would like to know if it is State Property, under Alachua County Sheriff's jurisdiction or City of Gainesville property due to safety and public health concerns.

County Manager Lieberman stated the Alachua County Sheriff has jurisdiction countywide. The homeless encampment is located in the City of Gainesville. She will notify Community Support Services Director Claudia Tuck and will get case managers out to the area to speak with them and attempt to provide them with services.

Chair Wheeler stated she has a request from Larry Green asking the Board write a letter of support for a grant to provide mental health services to the LGBTQIA+ community in and around Alachua County. The Chair stated she would like to submit a letter from the Board in support for the grant.

Commissioner Cornell moved to authorize a grant letter for Mr. Larry Green in support of the LGBTQIA+ community

2nd commissioner Chestnut

Chair Wheeler stated she attended the Labor Coalition meeting and there were concerns from citizens in the group about the Bradley family and the recent encounters with Mr. Bradley and the K9. Chair Wheeler states she is concerned about the way the dog was handled and would like to know how ASO conducts searches using K9 tactics.

Commissioner Prizzia asked for an update from ASO regarding their policies using K9s in searching and tracking people.
