**Background:**

Alachua County acquired property by Tax Deeds between February 20<sup>th</sup> 2019 and July 16, 2019 identified as tax parcels no. 11420-001-000, 09312-000-000, 11127-008-000, 11310-001-000, 11128-005-000, 10676-003-000, 09862-000-000, 10827-000-000, 10733-070-000, 11307-001-000, 11306-000-000, 10853-000-000, 11108-008-000, 10827-001-000, 11632-000-000, 10855-000-000, 11128-007-000, 10837-000-000, 11713-000-000.

These properties lie within the boundary of the City of Gainesville and pursuant to Section 197.592(3) of the Florida Statutes, lands acquired by the County for delinquent taxes in accordance with the law and which are located within the boundaries of an incorporated municipality of the County shall be conveyed to the governing board of the municipality. Once the Resolution and Deed have been executed by the Board Chair they will be forwarded to the City of Gainesville for recording in the public records.
