Background:

Analytical services are used for laboratory analysis related to monitoring of surface water, groundwater, stormwater and wastewater. Analytical data are an integral part of water resources protection and are used to evaluate water quality impairment and to determine compliance with water quality standards, total maximum daily loads (TMDLs), and facility permit conditions.

RFP 20-96 Annual Laboratory Analysis Services advertised on April 17, 2019 and April 24, 2019. The deadline for receipt of RFP 20-96 Annual Laboratory Analysis Services was June 19, 2019: three (3) vendors responded. The three responding vendors are ranked as shown above. Awarded vendors will be chosen based on task assignments.
