Award, Contract, Change Order 1 and Budget Amendment for BID 19-912 NW 91st Street Sidewalk Project 918-7903

### Recommended Action:

Approve the Award and Contract for BID 19-912 NW 91st Street Sidewalk Project 918-7903 to, Hartman Civil Construction Co. Inc., in the amount of \$347,325.00, plus a contingency amount of \$34,732.50, for a total fiscal impact of \$382,057.50, as the lowest, most responsible and responsive bidder meeting specifications.

Approve the Budget Amendment to move \$275,494.00 from Unallocated MMTM Funds to the NW 91st Street Sidewalk Project 918-7903.

Approve Change Order 1 reducing the contract amount by \$58,635.00 for a revised contract amount of \$288,690.00 plus the original contingency of \$34,732.50 for a total fiscal impact of \$323,422.50.

### Prior Board Motions:

January 2018 Board added the project to the FY18 CIP.

**Fiscal Consideration:**

The amount needed for the contract including contingency minus the change order of \$58,635 for project 918-7903 is \$323,422.50. An additional \$50,000 is needed for in-house charges. The amount currently available in account 354.79.7910.541.63.01 for this project is \$97,929. Therefore, the budget amendment in the amount of \$275,494 will cover the shortfall.

**Background:**

The project is to install a 6 FT wide concrete sidewalk on the west side of NW 91st Street from North Road to the existing sidewalk at 3800 block of NW 91st Street. This will require adding curb and gutter along a majority of the project and rebuilding driveways. Work is expected to commence in January 2020 and reach completion in Spring 2020. Work will be conducted in the daytime.
