Background:

The Southeastern States, especially Florida, have the highest levels of pest infestation in the country. It's very common for commercial buildings to be troubled by unwanted pests year-round in Florida, due to our climate. The need for annual pest control services is a necessity in order to provide a safe and pest free environment in the County buildings for citizens and staff.
