## Social and Economic Opportunity

### **Background:**

Alachua County solicited nominations for names of prominent, deceased, African American Alachua County citizens to be the inspiration for a “Call to Artist” for a bronze statue to be erected on the west lawn of the Alachua County Administration Building. Eleven nominations were received. For your information, nominations and/or photos of the individuals are provided in sharefile link attached to this agenda item. The Community Remembrance Project Committee shortlisted the nominations to their top three (Dr. Patricia Hilliard-Nunn, Dr. Cullen Banks and Reverend T. A. Wright), which were forwarded to the Alachua County Historical Commission for vetting.

The Historical Commission researched the nominees and found nothing of concern in their background. The Historical Commission made the following motion at their November 8 meeting, “provide the three highest ranking nominees to the BoCC with order noted (Dr. Cullen Banks, Reverend T. A. Wright and Dr. Patricia Hilliard-Nunn), and ACHC supports the possibility of recognizing all 3 individuals if this is possible with existing resources.”

The chosen nomination will be the inspiration for a Call to Artist for an artist to fabricate and install the bronze statue on the west lawn of the Alachua County Administration Building property.

The Community Remembrance Project Committee has asked the Board to consider a bronze sculpture of each of the three nominees.
