## **Background:**

This agreement will be used for roadway construction material hauling as needed; the County does not have trucks and personnel to handle all hauling needs. The agreement is utilized to haul limerock and mill for unimproved roads and for special projects. The original term of the agreement was through September 30, 2021.

This will be the second and final one-year renewal. Contracts will be used on an as-needed basis and hauling estimates are included in the department annual operating budgets and capital project budgets. This contract has an annual not-to-exceed amount of \$500,000.

Bid 20-65 Annual Roadway Construction Material Hauling Services advertised on January 15, 2020 and January 22, 2020. The Deadline for receipt of Bid 20-65 Annual Roadway Construction Material Hauling Services was February 19, 2020; two (2) vendors responded.
