Local Workforce Development Board 9 (LWDB 9) oversees career center operations, provided by CareerSource North Central Florida (CSNCFL), in Alachua and Bradford Counties and receives funding by State program year (July 1-June 30) through formula, discretionary and dedicated grant purposes. LWDB9 received new funding for WIOA Adult in the amount of \$524,159.00 for the period of July 1, 2022 to June 30, 2024, WIOA Dislocated Worker in the amount of \$509,160.00 for the period of July 1, 2022 to June 30, 2024, WIOA Youth in the amount of \$1,123,076.00 for the period of April 1, 2021 to June 30, 2023, WIOA Youth in the amount of \$1,064,693.00 for the period of April 1, 2022 to June 30, 2024, Welfare Transition Program (WTP) in the amount of \$197,763.00 for the period of July 1, 2022 to September 30, 2022, Wagner-Peyser in the amount of \$129,864.00 for the period of July 1, 2022 to September 30, 2023, Disabled Veterans (DVOP) in the amount of \$14,526.00 for the period of October 1, 2021 to December 31, 2023, Local Veterans (LVER) in the amount of \$10,743.00 for the period of October 1, 2021 to December 31, 2023, and WIOA Rural Initiatives in the amount of \$62,500.00 for the period of July 1, 2022 to June 30, 2023.
